IF THE CONTRACT IS NOT FULFILLED BY THE EXPIRATION DATE, THE MERCHANDISE WILL BE PLACED UP FOR SALE AND ALL MONIES PAID WILL BE FORFEITED AND ARE NON-REFUNDABLE. THIS CONTRACT CANNOT BE EXTENDED.
